I – STUD SERVICE FEE

II - CONDITIONS STUD OWNER AGREES TO

1. Take adequate care of the bitch while she is under stud owner's responsibility, unless the bitch is handled by the owner at the place of mating.
2. Have the stud dog in good physical condition, up to date on vaccinations.
3. Provide one return stud service (up to two matings) of the same dog to the same bitch if no pregnancy results from the first mating, at no charge.
4. If the stud is no longer available for the return service, the stud owner reserves the right to offer a different stud to the bitch owner.
5. Sign litter registration promptly and return to bitch owner.
6. If the matings cannot, for whatever reason, take place naturally, the stud owner agrees to proceed by artificial insemination.

III – CONDITIONS BITCH OWNER AGREES TO

1. Pay the agreed stud service fee before the bitch is serviced.
2. Provide veterinary certificate of current annual vaccinations including Bordetella (kennel cough) and a clear Brucellosis test dating up to 14 days prior to first mating.
3. Send bitch in good health and in season.
4. Notify stud dog owner in writing no later than 70 days after mating if no pregnancy results from the mating. Failure to do so will result in no return service provided.
5. Keep the bitch properly confined following the breeding to ensure no other dog could mate her accidentally before and after the mating season is finished.
6. If the matings cannot, for whatever reasons, take place naturally, the bitch owner accepts to proceed by artificial insemination.

7. Pay for an additional service fee of 50\$ per additional mating if the bitch owner wants more than the 2 matings offered in the base price, during the same season.

8. Pay for any and all veterinary and financial arrangements, including, but not limited to traveling expenses, emergency vet care related to this breeding, etc.

9. Pay an additional boarding fee of 15\$ per day if the bitch is left with the stud owner for more than 7 days.

10. Agree to not knowingly sell or transfer puppies whelped as a result of this mating to any person or firm connected with the business of resale or wholesale of dogs such as brokers, pet shops or puppy mills.

IV - OTHER CONDITIONS

1. One puppy born alive constitutes a litter. No return service will be provided.

2. No additional stud service will be provided if the bitch fails to conceive from the return service. A new contract will need to be signed and the stud fee paid again for any further matings.

3. If the bitch owner voluntarily leaves the bitch with the stud owner, the stud owner is not liable for any death, sickness or accident that may occur during this time.

4. Should an issue arise in relation to this contract, it is to be resolved in the legal district of Longueuil. The contract will be enforced and interpreted under the laws of the Province of Québec. This contract represents the entire agreement between the parties. No other agreements, verbal or implied, are included.

5. Both parties agree to the entire content of this contract by signing below. The signature of both parties renders this contract binding between them.
